Most of our purchases comprise raw materials (hydrocarbon residues from a variety of sources) and materials used to build our units.



Ecoslops expects its suppliers to help create global value for the economy, the environment and society, and to manage CSR risks. We therefore ask our suppliers to make a commitment to:


- Respect Human Rights
